### ***President's Message***

Sssh! If you're quiet, you can almost hear Federation committees working. The Budget Committee has been meeting since the County Executive released the proposed budget in late February. Each of our committee chairs were tasked with making recommendations in their specialty areas to the budget committee. To complete the budget review in the limited time available, they set up a very aggressive schedule. Within a week, the committee chairs provided an outline or sketch of their portion of the draft resolution to the committee scribe, who immediately packaged the outlines and distributed to them to the entire Budget Committee, with full recommendations coming the following week. These were integrated and edited for uniformity, and distributed once more. The entire budget committee then convened in person to discuss the recommendations overall, giving priorities across the entire package. After a clean-up of the proposed resolution, the draft was distributed almost a week in advance to the Federation Board for their review at the Board meeting, held a week before our membership meeting.

Since this edition of the Bulletin was prepared before the Board finished its review, we don't have the actual resolution for you to review, however we have a link to where the Board-approved document resides: <<<http://www.fcfa.org/resolution/ResolutionFY2011BudgetDraft100318.pdf>>>. This is the document to be reviewed and adopted by our membership at the March 25 meeting. As you can see from the steps I've outlined above, our positions will have been thoroughly vetted by probably the only countywide citizens' review body with no axe to grind.

At the same time that our Budget Committee has been hard at work, our Citizen of the Year Award Selection Committee is reviewing the applications received during the nomination period. The membership of our Selection Committee is unique among all the other Federation committees in that other citizen organizations, such as the League of Woman Voters and the Fairfax County Arts Council, are specifically invited to play a part in reviewing the nominations. I don't know how many nominations were received, but have been told that there are several strong candidates under evaluation. The committee expects to announce the honorees at our March meeting.

We look forward to seeing you on March 25th, to share the names of our Citizen of the Year honorees as well as determine the position the Federation will take on the fiscal year 2011 budget. Although the Budget Committee has spent hours coming up with draft wording, the final word is the property of the Federation members, and our decisions and priorities are what will be presented to the Board of Supervisors at the budget public hearings. Our voice needs to be heard as the county reacts to the financial crises in which we find ourselves. Make your voice part of ours and join us at our March 25th meeting!

Membership Meeting of February 18, 2010

**DRAFT MINUTES**

(for approval at the March 25, 2010 membership meeting)

The February 2010 Meeting of the Membership of the Fairfax County Federation of Citizens Associations was called to order by First Vice President Tania Hossain at 7:35 p.m. in the general meeting room of the Packard Center. Present were 17 participants and three presenters from the Fairfax County Park Authority and the Tysons Task Force. (Attendance list is attached to file copy.)

**Program: Fairfax County Park Authority Budget**  
**William G. Boule, Chairman of the**  
**Fairfax County Park Authority Board**

Mr. Boule described the scope of Fairfax parks: 417 parks covering 23,000 acres—10% of the county's land area, 300 miles of maintained trails, and annually hosting 19 million visits and serving a quarter million athletes.

Mr. Boule addressed a pending anticipated budget reduction of 15% which follows a 31% reduction over the previous two years. Measures to implement a 15% funding reduction would probably result in layoff of more than 50 staff, reduction in use of outdoor lighting, reduction in use of portable toilets, fewer hours of operation of many facilities, and a reduction of activities classified as environmental stewardship. Mr. Boule urged the homeowners and civic associations and their members to lobby for adequate park funding.

In the event that funding cuts do occur, Mr. Boule would prefer to defund positions instead of eliminating the positions.

When asked about a possible merger of the Department of Recreation and the Park Authority, Mr. Boule stated that a task force is studying the issue; however the Park Authority is not represented on the task force. He described the Department of Recreation's mission as primarily scheduling the use of facilities.

In response to another question, Mr. Boule advised that Fairfax County provides 70% of the funding for the Northern Virginia Regional Park Authority. He had no position whether that contribution could be reduced. Cindy Messinger, Deputy Director, Fairfax County Park Authority, also participated in the meeting.

**Program: The Future of Tyson's Corner**  
**Clark Tyler, Tysons Land Use Task Force Chair**

John Jennison, former Federation President and current member of the Tysons Task Force, introduced Mr. Clark. (This section of the minutes was written by Fred Costello, Chairman of the Land Use Committee, and edited by the Recording Secretary. The table and schedule of future meetings below were not presented in the meeting.)

Clark Tyler is a semi-retired businessman and former government official. Active in civic affairs, Mr. Tyler has served since 2006 as Chairman of the Tysons Land Use Task Force: a group of local residents, business people, property owners, and other stakeholders charged to make recommendations to the Fairfax Board of Supervisors on the new Tysons Corner Comprehensive Plan, specifically what should Tysons become and how do we get there?

The Chairman's major task was obtaining a consensus and commitment from 30 competing interests and over 50 land

owners in the Tysons area. He participated in 450 meetings to learn the concerns of residents and employees in the Tysons area. He held 45 three-hour workshops at which people of different interests were assigned to small groups that developed ideas and positions, then the small groups presented to all attendees. He synthesized the results into objectives and developed the all-important implementation plan.

One goal was to obtain a balance between residences and jobs. At present, there are 18,500 residences but 112,600 jobs; therefore, most employees must drive daily into Tysons. The 18,500 residences are all high-priced, whereas 20% of all housing should be affordable/workforce housing. In an expanded Tysons, highway needs would exceed what is possible to implement if the current automobile-based transportation model was employed. Public transit is necessary. At present there are 40 million square feet of parking space, which serves 46 million square feet of developed space. The accompanying table, taken from the third draft of the Tysons Comprehensive Plan, shows the differences between recommendations of the Task Force and the other planners. The Task Force wants a greater resident/worker balance, with the population living in Tysons and providing a large share of the Tysons work force.

The tendency of planners has been to focus on individual developments, whereas Tysons requires an integrated plan. In planning for Tysons, planners must convert from their current suburban mentality to an urban mentality and apply urban—not suburban—planning standards.

The integrated model has to consider the total infrastructure: roads, utilities, schools and other community services, etc. Consideration has to be given for affordable housing, workforce housing, parks, open space, storm water handling, pocket parks, etc. Clark said that as much open space should be provided as could be extracted from the developers. He did not have any recommendation concerning the percent of land area that should be open space. He did state that in urban settings "pocket parks" are more feasible than large parks.

The traffic modeling (done by Cambridge Systematics) is not

reliable because too many assumptions had to be made. Planning to address traffic from a Level of Services viewpoint encourages road expansions, whereas public transit should be encouraged. A National Academy of Sciences study showed that doubling density itself would reduce vehicle miles traveled by 25%. In Arlington (Ballston), 17% of people do not have automobiles. The goal of Traffic Demand Management (TDM) is to reduce traffic. For example, TDM encourages people to walk and ride bicycles to work. Unfortunately, the present Tysons has noncontiguous sidewalks and no bicycle paths.

Although Metro Rail is important, a circulator bus and shuttle buses are necessary to make Metro Rail successful. The circulator bus should be funded by the land owners so that it is free to the users. To be effective, it must also be frequent and visible. Proffers, which are essential due to the Dillon Rule, should support the circulator-bus roadway costs.

In answer to the question when the Planning Commission and Task Force consensus plan will be submitted to the Board of Supervisors, Mr. Clark predicted April or May.

**Application of Local Composite Index**

The Federation sent a letter to the governor urging that the Local Composite Index (LCI) be recalculated this year according to the normal two-year schedule, rather than being delayed by a year as proposed in the budget submitted by the former governor. An LCI recalculation delay would have resulted in Fairfax County schools receiving 61 million dollars less. #### **Citizen of the Year Award and Banquet - John Jennison**

Nominations for the Citizen of the Year Award are open until February 28, 2010. See <http://www.fairfaxfederation.org/coy1.htm>. The banquet will be held April 25 or May 2.

Douglas Koelemay of SAIC indicated his company enjoyed its 2009 sponsorship and would like to renew its sponsorship in 2010. The Washington Post is only doing in-kind donations this year, such as providing items that could be auctioned at meetings, speakers at events.

#### **Education - Charlie Dane**

In his budget, the superintendent has asked for \$58 million more than the county provided last year. The school board revised this request to ask for \$81 million more.

The governor now supports recalculation of the LCI. If the General Assembly approves, this provides \$61 million that Fairfax County had expected not to receive.

Today the governor proposed the state reduce K-12 funding by \$730 million; Fairfax County's share would be about \$60-65 million. If the General Assembly agrees to this reduction, it may concurrently remove the standards of quality requirements for school districts; however this could be constitutionally challenged.

By law, the budget process requires the Board of Supervisors to advertise a property tax rate for the coming year that cannot be exceeded when the Board later establishes the actual tax rate. Anticipating possible cuts in state funding, Charlie asked if the Federation ought to recommend that the Board set an advertised rate high enough that would permit the county to later set a high enough property tax rate to offset the worse case of state funding cuts. In informal discussion, participants decided that the budget process has too many changing variables to make such a recommendation that this time and that our own board should decide later.

Charlie reported that a bill has been introduced in the General Assembly to allow counties to impose meals tax without holding a referendum.

##### **Other Organizations' Environmentally Focused Meetings**

The upcoming *Greening Fairfax County* seminar might of interest to the Federation membership. The sponsor, the Fairfax County Restoration Project ([www.fcrpp3.org](http://www.fcrpp3.org)), is a new environmental public-private partnership. Its leader, Amy Gould, is doing an impressive job of bringing players together and would probably be a valuable partner for the Federation. She has focused on habitat restoration in the wake of the HOT lanes project and on nudging Dominion Power toward encouraging native species in their easements.

The Virginia Conservation Network held a light breakfast and roundtable this morning in Richmond moderated by the Ambassador of Norway to the United States on "An Arctic Imperative: Local Implications for Current Climate Science and Diplomacy".

The Sierra Club is meeting Senator Webb's Falls Church office on February 19 to urge his support for the Clean Air Act and is soliciting citizens to attend that meeting. Although the senator will be overseas, participants will meet his staff and demonstrate outside by the highway.

The February Fairfax Environmental Network meeting was cancelled for snow. The next meeting will be March 8.

#### **Challenge to EPA's Greenhouse Gases Endangerment Finding**

Virginia's attorney general Ken Cuccinelli filed a petition on February 16, joining Texas in challenging the U.S. Environmental Protection Agency's (EPA) December 7 ruling that it would regulate greenhouse gases as it would air pollutants under the Clean Air Act. The U.S. Supreme Court declared in 2007 that carbon dioxide and other greenhouse gases are pollutants that the U.S. EPA could regulate if it found these gases endanger public health. The Attorney General said he has asked the U.S. EPA to delay final consideration of that finding so "newly available information" can be reviewed and said that he would seek a legal challenge of the U.S. EPA's endangerment finding. The Sierra Club criticized the challenge, calling it a waste of taxpayers' money.

#### **Cool County Initiatives**

Roger Dietrich reported that Fairfax County was behind other local jurisdictions in following through on the Cool County initiatives. He contended that the task had been entrusted to county staff without sufficient oversight; citizen oversight is needed. The Environment Committee will address this need.

#### **Land Use - Fred Costello**

Reston Task Force meetings were cancelled due to snow. Meetings resume next week; the first will feature a presentation on transportation.

The Federation was asked if it was undertaking any serious examination of corruption and incompetence in parts of the Fairfax County government. Informal discussion yielded an answer of no, as looking for corruption and incompetence is outside our charter. The Federation does actively identify problems with government and proposes ways to improve governance.

Bob Jordan, representative of the McLean Citizens Association (MCA), reported that two Fairfax County planning commissioners, Jay Donahue and Walter Alcorn (Mr. Alcorn chairs the Planning Commission's Tyson's Corner Committee) will speak at the MCA's winter meeting on March 2 at 7:30 p.m. at the McLean Community Center, 1234 Ingleside Drive, McLean. The topic will be a presentation and discussion on the final plan for Tysons Corner being considered by the Fairfax County Planning Commission for recommendation to the Board of Supervisors. The meeting is open and all members of the Fairfax County Federation of Citizens Associations are cordially invited. The Fairfax County Tree Commission seeks nominations for its 2010 Friends of Trees Awards. The awards are presented to individuals or organizations that have demonstrated superior actions in preserving, protecting or planting trees. The following types of projects or programs may be nominated:

- Preservation: projects or programs for land or easement donations, or appropriate arbor care.
- Education: projects or programs that create publications, interpretive trail development, tree marking with identification tags, or make presentations to the public about preservation, protection and planting of trees.
- Planting: projects or programs that conduct seedling plantings, riparian restoration plantings and heritage species plantings.
- Maintenance: innovative projects or programs that share the responsibility for long-term maintenance without traditional funding sources.

Projects or programs must have been completed in 2009, or started in 2009 with an anticipated life of more than one year.
