
Directions to Braddock Hall

Membership Meeting Minutes

Meeting held at: Braddock Hall, 9002 Burke Lake Road, Burke, VA on Thursday, October 21, 2010, 7:30 p.m.

Draft submitted for approval at Nov 18, 2010 meeting

Second Vice President Don Hinman presided and Corresponding Secretary Esther Ferington took these minutes. Attendance list is attached to the file copy.

PROGRAM

There was no guest speaker, because the primary purpose of the membership meeting was presentation, review, and approval of the Federation legislative program, which had been previously distributed online.

ADMINISTRATIVE TOPICS

Minutes: Prior to turning to the legislative program, Second Vice President Hinman reported that the draft membership minutes for the previous meeting would be considered for approval at the next membership meeting in November, rather than at this meeting.

Charles Dane noted that a previous set of minutes had recorded that a joint budget meeting between the county and the school board was to be October 23; in fact, the meeting is October 26.

Treasurer's Report: Treasurer Scott Schegel distributed and discussed the Treasurer's Report. By a unanimous vote, the report was received and filed.

Human Services - Needs Chair

Newsletter: Don Hinman noted, with Newsletter Editor Fred Costello's concurrence, that the deadline for materials for the next issue of the Bulletin is November 1.

NEW BUSINESS

Fairfax County Police: With the prior permission of the chair, Second Vice President Don Hinman, and of Federation President Tania Hossain, whom he had contacted before the meeting, Gabe Goldberg, representative of the Walnut Hill Association, reported on a fundraising project based on his experience as a citizen who attended the 10-week (one evening a week) Fairfax County Citizen Police Academy, billed as a glimpse behind the badge, which he described and strongly recommends. Past participants and related volunteers are raising money for a Police Department canteen, which is a mobile unit that responds to major incident scenes to supply food and rest areas for police who may be onsite for many hours or multiple days, through sales of a 2011 entertainment discount book.

Board and Committee Reports

Budget: Carey Campbell, Charles Hall: No report.

Citizen Association Services: Don Hinman: No report.

Education Committee: Charles Dane reported that the Fairfax County Public Schools held an "education summit" on the previous Saturday, which had a big turnout. The keynote speaker, Ken Keys, emphasized the four Cs, critical thought, creativity, collaboration, and communication. FCPS already has these areas covered in its school governance documents, expressed slightly differently, and the school board may adjust the wording. He also reported that the Fairfax County PTA Council will meet on October 28 to look at the VRS retirement fund and how to make it solvent, since it is not now.

Environment Committee: Chair Flint Webb reported he had attended a meeting of an advisory board related to the Chesapeake Bay regarding the upcoming TMDL (total maximum daily load) levels related to all streams feeding into the Chesapeake Bay, standards which are expected to be very contentious. The website for the TMDL is <http://www.epa.gov/chesapeakebaytmdl/> and comments can be made through November 8. Several aspects concern homeowners, especially those with septic systems. Others will relate to regulations. He asked at the meeting whether the advisory board had anyone representing homeowners and was told only that many members of the board are themselves homeowners. He wonders whether there is a potential role for the Federation in participating on this board. Roger Dietrich noted that the county is now completing its final watershed plan, having done all the others. He said this is essentially a wish list of projects that could be used for a given watershed, but there are funding issues.

Human Services: Position vacant.

Land Use Committee: Chair Fred Costello reported that the recent Vision subcommittee meeting for the Reston planning task force revealed considerable disagreement on its purpose.

The Braddock District Council is also moving its meeting night from the second Tuesday to the second Wednesday of the month. Supervisor Cook is scheduling another follow-up meeting on the Woodson Parking Lot. The Braddock, Mason, and Fairfax City working group met again to explore issues of common interest. He also reported on the major renovation of University Mall. Charles Dane added that the Braddock budget committee will meet on November 3.

presided over the ensuing discussion of the proposed legislative program. Jeff Parnes moved approval of the program and was seconded by Bill Hanks.

As in prior years, all friendly amendments and wording or word-smithing changes to the legislative program will be incorporated in the revised legislative program and are not recorded here. No unfriendly amendments were put forward and thus no votes were held on amendments to the program.

In addition to those named above and other attendees, Leonard Bumbaca represented the Education Committee in the discussion as one of the committee's three co-chairs and put forward verbal amendments with a particular emphasis on the education portions of the program.

The program, as amended, was approved on a vote of 18 in favor and 3 against, with no abstentions.

Federation Testimony at the Oct 5, 2010, Redistricting Hearing

Greetings Members of the House Redistricting Subcommittee: My name is Tania Hossain and I serve as the President of the Fairfax County Federation of Citizen's Association. In its 70th year, the Federation is the oldest association for the County's Homeowners, Civic and Community organizations. We work together in a non-partisan manner and advocate on issues that impact all Fairfax County residents. To that end, on behalf of the Federation, it is my honor and privilege to inform you that the Federation supports the non-partisan and competitive Iowa Model as Virginia's 2011 redistricting process.

We are well aware that in most states, as in Virginia, the State Legislature draws the congressional and state legislative district lines. And since in its final form, a redistricting plan is a bill, it can have many sources of origination and face many political challenges. Like many bills that have gone through the General Assembly, most of them have entailed some sort of a party political process. The redistricting process in Virginia has undergone its share of the political process as well. We have duly noted that the House and Senate Committees on Privileges and Elections have adopted many elements of the Iowa Model in Resolution No. 1 that was adopted on April 3, 2001. However, the entire process still resides and is driven by the General Assembly and thus subject to partisan politics.

According to the Division of Legislative Services Drawing the Line 2011 report, there have been measures taken to modify the General Assembly's role to establish either an independent redistricting commission by a constitutional amendment or an advisory redistricting commission by a statute or to study the redistricting process. Since 2001 more than 40 constitutional amendments were offered to turn redistricting work over to an independent commission; 30 bills were introduced to create an advisory redistricting commission; and over a dozen resolutions were proposed to study the redistricting process. All attempts have failed, states the report.

If the Iowa Model were to be adopted, the Virginia redistricting process would be under the purview of a nonpartisan commission. The Commission would take into account only the following four factors in determining redistricting eligibility of a district: population, contiguity, compactness, and existing boundaries of governmental units. The population of legislative districts must be equal, districts must form a single unit, districts must not be elongated or in other strange shapes, and to the extent possible districts should not divide cities or counties. Perhaps the most important ramification of the adoption of the Iowa Model would be that it would be prohibitive for the Commission to engage in political gerrymandering because they would not have access to the information necessary to engage in that practice. Just that one very aspect would make the Iowa Model one to emulate and one which would strengthen Virginia's redistricting process by simply taking it out of the political process.

We understand what a difficult task you have ahead of you and we thank you for all your work on making Virginia redistricting a non partisan process. On behalf of the Federation, I wish all of you the best in your deliberation and thank you for this opportunity to share our thoughts.

Home Hazards

From our Public Safety Chair, Gail Parker

The following information was obtained from *Senior Living Magazine*. Please be diligent about removing hazards around the home. Many Americans are injured in and around their own homes. In 1981 (according to the US Consumer Product Safety Commission) an estimated 622,000 people over age 65 were treated in hospital emergency rooms for injuries associated with products they live with and use everyday.

Safety tips: Keep electrical and phone cords out of the walking paths to avoid tripping over the cord. Remove cords from under furniture or carpeting and replace damaged or frayed cords.

Use tape, not nails or staples to keep cords in place. Do not overload extension cords or outlets (standard 18 gauge extension cords can carry only 1250 watts.).

Small rugs and runners should be slip-resistant and replaced when backing becomes less effective.

Post emergency numbers near the telephone or save them on your cell phone. Be sure at least one phone is accessible in the event an accident leaves you unable to stand.

Be sure smoke detectors are on every floor and that the detectors are working properly.

An electrician should check wiring if any outlets or switches are warm or hot to the touch. Unplug cords and do not use the switches until the electrician has checked. Wiring should not be exposed. Use bulbs wattage recommended for the appliance. Use 3-pronged plugs in 3-hole outlets.

If heaters are used, make sure the room is adequately ventilated and that the heater is placed away from flammable materials such as curtains, rugs or piles of paper. Have an emergency exit plan in case of a fire complete with a meeting place outside your home. Practice the plan from time to time to make sure everyone is capable of a quick and safe escape.

In the kitchen, keep flammable items away from the range. Wear short-sleeves or close fitting sleeves while cooking. Turn pan handles to the back of the range and use ventilation fans while cooking. Keep appliance cords away from sink and range areas. Good lighting can help prevent burns and cuts. Consider purchasing a good step stool rather than using a chair. A step stool should have a handrail to hold onto while standing on the top step and should be stable. Discard step stools with broken parts.

Keep exits and passageways clear of objects and well lit. Use non-skid mats in the bathroom tub, shower and on the bathroom floor. Keep electrical appliances away from the sink and tub. Install sturdy grab bars to help you get into and out of the tub or shower. Make sure the water heater does not heat water above 120 degrees can prevent burns and lower energy bill. Keep medications in the container they came in and away from the reach of children. Discard when out of date.

Do not smoke in bed. Do not sleep with heating pad turned on. Make sure the telephone and the light switch is close to the bed in case of an emergency.

Make sure lighting is good in basements, garages, workshops. Use only fuses that are the correct size for the circuit. Store flammable liquids away from fires, properly labeled and in non-glass safety containers.

Home Hazards (continued)

Make sure handrails on stairways, steps and decks are sturdy, in good condition and well lit. Replace frayed or worn treads and replace worn carpeting. If paint is used outside, use a rough texture or abrasive strips to prevent slips. Make sure steps are even and of the same size and height. Use light colored paint to help see the steps better at night. Add extra lighting. Remove all objects from the stairway.

Reston East Park and Ride

The Fairfax County Department of Transportation (FCDOT) recommends Fairfax Connector passengers and other commuters utilize three Reston area park and ride lots starting November 28, 2010 to mitigate the loss of up to 200 spaces from the partial closure of the Reston East Park and Ride. Reston East is the location of the future parking garage for the Wiehle Avenue Metrorail station.
