#### Old Business

• Dues and voting structure for associations with over 5000 members | Charlie—In June Charlie mentioned that the Burke Centre Conservancy Home Owners Association (HOA) represents over 5800 homes and is not a member of the Federation. He thought its mega-size mightn't be consistent with the current dues and voting rights scheme of the Federation, which is:

Membership Strength	Annual Dues	Votes in Federation Deliberations
< 100	\$20	1
100 - 1000	\$40	2
> 1000	\$60	3

- Charlie questions whether an extra large HOA should have greater voting rights and whether enhanced voting power would help entice mega-sized HOA to join the Federation. He indicated that he would obtain statistics on the sizes of member and non-member associations in the county that are of larger size and report his findings tonight.
- Status of ongoing review of the Implementing Policies and Procedures document Bill (Absent) <a href="http://www.fcfca.org/bylaws/Policies&Procedures030724.pdf">http://www.fcfca.org/bylaws/Policies&Procedures030724.pdf</a>>
  - o The initial division of labor for our 3-member P&P Review Committee was:
    - Jennison--first draft of complete rewrite of Supplement B
    - Hanks & Fee-- possible modifications to everything preceding Supplement B
  - o John Jennision's intent is to have the P&P updated for the COY and have reference to a further, more flexible book for the more detailed instructions
  - o John Fee is updating pages 1-18 to include "mission statements" for each committee.
    - The environmental committee includes this language "b) review proposals to establish, expand, or reduce environmental programs before the Congress or Virginia General Assembly." Similar language could be included in the community services committee, education committee, and public safety committee—in the event that the Federation wished to comment/advocate on national or commonwealth activities. The limitation on review of proposal by the legislative branch seems unduly restrictive inasmuch as executive agency programs may also interest the Federation. (That said; this may be far more than the Federation committee may be able to undertake, but why should this document prohibit such review if the Federation wants to do it).
- Thinning of Federation storage Jeff
  - The Board needs to review our remaining files for retention purposes: Task after each board meeting the President and Corresponding Secretary (and whoever else would like to join us) go through one file cabinet drawer to determine what to retain, archive or recycle.
- Resolution on support for a transit study Carey & Roger (Absent)
  - At last month's board meeting the board passed a resolution in support of Congressman Connelly's bill
    calling for stimulus money to be used to study expanding transit (Metro) in No Va. The bill was furnished to
    our elected and other officials in the county, state and federal governments by Esther. We plan on
    presenting the resolution to the membership at our September meeting.
- · Signs to direct motorists to the VRE stations Carey
  - Stimulus money will be used to purchase 120 highway signs to direct motorists to the VRE stations. Carey was asked to present his research on the matter (including current plans for the 120 signs and cost of options) and to draft a resolution for Federation consideration in support of installing electronic sign boards along highways leading to the stations that can announce real-time VRE information such as arrival time of next train and delays.

  - o Citizen Budget Advisory Committee
    - Braddock District Council has asked the Federation to brief their Citizen Budget Advisory Committee. Kosmo has agreed to represent the committee to explain the county budget structure and how the Federation Budget Committee attacked the beast.
    - This might make a newsworthy article "Federation to help district council in budget examination that could be sent to all Supervisors and other district councils."

  - o I spoke to Roger Diedrich. He has agreed to be acting Environmental Chair for this Thursday's meeting and will help me find a permanent co-chair. He would like to propose that either the Federation endorse a letter the Sierra Club is drafting about the County's Energy Policy not going far enough to reduce greenhouse gasses or he may have a Resolution along the same lines that he would like to bring up.
    - Roger reports that the attached 6-15 policy is what some in the Sierra Club found to be unacceptably weak.

- o There is a new issue down in the Lorton area. I talked to Mike Grogan (MGrogan@wrginc.com) of the South County Citizens Federation. The County is considering adding a new landfill area in South County. Opening a new landfill contradicts a stated (2004) County policy. The idea of opening a new landfill was raised and developed in meetings of an unpublicized internal County committee composed of staff from the departments of Public Works, the Park Authority, Planning and Zoning, and Finance, without any input from the impacted community. Only via a Freedom of Information Act request did the community learn of the staff committee's intent. The two issues are (1) reversing the policy of no new landfills and (2) reversing the transparency policies of the County by secret meetings that impact South County citizens, without involving the citizens.
- o There is another aspect of the South County issue that I don't know how to formulate. ESI, an engineering company, proposed to the County to expand its private construction-debris landfill and continue its policy of enhancing the community. The County accepted the idea but, in its secret meetings, planned to do the same but under its own auspices, with a new landfill rather than ESI's, implying that the County can do the job cheaply because it does not make a profit. As an engineer, with my own engineering company, I have seen this process before: the government taking over a creative idea proposed to it by a private enterprise.   - Kosmo provided the following suggestion for better handling of long resolutions like the Legislative Package and the County Budget, although it might take a change in the Bylaws:
    - o Do the nitty-gritty and wordsmithing work at two (maybe even three) sessions of the Board, inviting the Membership to attend and comment too,
    - Even though they maybe could not vote (or put into the Bylaws that they can vote in special joint Board/Membership meetings), and present the result for an up-or-down vote only (except maybe for errors of fact) at the Membership meeting.
    - o Those Members who care enough about the issues should attend the "working sessions". As it is now, too much time is spent rehashing the same issues at both the board meetings and the membership meetings for these long, complicated resolutions. The membership meeting is probably not the place to do it.
  - Bill appreciates Kosmo's idea as a constructive proposal for consideration, but just disagrees;
     Our current three step process of (1) committee initiation; (2) Board refinement, and (3) Membership Meeting finalization suggests THREE TIMES IS ENOUGH

    - o He believes that the Federation should support this motion and also believes that we are best served when we move with what is being proposed instead of proposing what be clearly out of reach.
    - o Our thoughts? Could and should the Federation Board prepare a motion at our August meeting for membership consideration in September?
  - · Carey comments:
    - A Federation Resolution calling on Congressmen Moran, Connolly, and Senators Webb and Warner to include these appropriations: \$2 Billion for Metrorail to Ft Belvoir and \$500 million for light rail to Ft Belvoir in Fy2010 DOD budget.

- The full House has approved \$630 Billion, the Senate appropriations committee \$680 Billion. Moran is on House appropriations committee. Rail funds can be inserted on the floor of the Senate, and in the House Senate reconciliation.
- Further: There are funds in the DOD budget for a great many diverse items beyond both guns and butter.
   The necessary rail to get to the expanded BRAQ bases should be included in FY2010. Provided need rail appropriation first. Build the needed Rail before base expansions.
- o With all due respect to a fine public servant, the Congressman's proposal doesn't solve the problem. The rail appropriation provides the positive solution to grow the economy.
