  - Chairman Sharon Bulova and the members of the Greater Washington 2050 Coalition are very pleased to share with you the draft report of the Coalition, Region Forward - Greater Washington 2050: COG's Vision for the National Capital Region in the Twenty-First Century.   - The report reflects more than a year and a half of work by the Coalition and input provided as recently as October 2, when the Coalition voted to advance the draft report to the COG Board of Directors.
  - The draft report reflects several suggestions made on October 2, including: clarified next steps by COG in the introduction; additional "smart growth" examples in different area jurisdiction; and better graphics and photos. Some larger issues, such as possible target and indicator substitutions will be revisited or clarified as part of the public review and comment phase prior to Coalition action in December.
  - On October 14, the COG Board released the report for extensive COG member, stakeholder and public review and comment. The draft report will be widely released, coupled with aggressive outreach to COG member governments and business, civic and environmental stakeholders, and media, social networking and public engagement as well. All of that outreach and input will come back to the Coalition when it meets on December 11 to review comments and adopt a final report for action by the COG Board on January 13, 2010.

  - o FY 2011 Budget Community Dialogues
    - THE CHALLENGE - Fairfax County is projecting a significant budget deficit for FY 2011 (beginning July 1, 2010). We are in the midst of a multi-year, cyclical downturn requiring that county decision-makers continue to make expenditure and revenue adjustments. Our ongoing challenge is to develop a budget with an appropriate level of services that are both sustainable and acceptable to the community.
    - THE RESPONSE - Fairfax County Government and Fairfax County Public Schools invite you to register and attend one of 12 Community Dialogues being held this Fall to share your feedback on the impacts of recent budget reductions as well as seeking for solutions to close the FY 2011 budget gap. County decision-makers will use your input as a key factor to help guide the development of criteria for making budget decisions.
