

Board Meeting Minutes

August 25, 2011

Approved September 22, 2011

The August meeting of the Board of the Fairfax County Federation of Citizens Associations was called to order by President Tania Hossain at 7:30 p.m. at the Packard Center in Annandale.

By unanimous vote, the board accepted the president's nomination and approved the appointment of Tania Hossain as the Federation's representative to the Fairfax Partnership for Youth.

Tania announced that Vice President Joe Gibson plans to incorporate Federation representatives into membership programming. Our representatives will be invited to participate in meetings when the program relates to the mission of the organization where they represent us.

New Business

Audit Committee Report – Bill Hanks

Bill presented the audit committee's report of financial records on July 19, 2011; the committee agrees with the treasurer's statement of the July 1, 2010, prior balance, income and expenditures since, and current balance. Committee members were Bill, Charles Dane, and Art Wells. Per the Policies and Procedures, the committee shall present its report at the regular meeting in September.

Second Authorized Check Signer—Tania Hossain

Per the Policies and Procedures, “The TREASURER shall designate, with approval of the PRESIDENT, one other Officer to be a bank account signatory authorized to make disbursements in the absence of the Treasurer. When a payee is one of the two authorized check signers, the check shall be signed by the other authorized signer.” Jeff Parnes has been designated as the second authorized check signer.

Board & Committee Reports

Budget—Carey Campbell and Charlie Hall

The county’s actual revenues are exceeding the forecasted revenue. The Board of Supervisors (BOS) is to decide in early September how to allocate the unexpected additional revenue. The Federation board addressed whether to make recommendations to the BOS. The Federation board decided that the Federation’s 2012 Budget Resolution provides our position.

Citizen Association Services—Don Hinman

Tania reported that Don has been visiting citizens associations to see how the Federation can best assist them.

Jeff reported that a proposed bill in the General Assembly would require homeowner association officers to undertake ethics training.

Citizen of the Year—Jeff Parnes

Citizen of the Year nominations will be accepted starting December 1, 2011.

The March 25, 2012, banquet will be at the Crowne Plaza Tysons Corner as in 2011, at the same rates as in 2011.

Pending events:

- Electronic Sunday: August 28 at the I-66 Transfer Station and September 25 at the I-95 Complex
- Green Building workshop on revision of Fairfax County’s Green Building Policy: September 6
- Air & Waste Management Association Networking Meeting: September 15 at GMU—Arlington. The subject will be the Fairfax County inventory.

The environmental committee proposes specific revisions to the Green Building Policy. After discussion, the Board decided to move on this committee proposal. Further editing will take place offline and the Environmental Committee will present the proposal to the membership at the September 15 meeting for submission to the BOS public hearing scheduled in October.

Tania noted that the Federation’s September program is the environment.

Human Services—Cherie Lejeune

Tania announced that Steve Gurney, founder of the [Guide to Retirement Living SourceBook](#), will present at the Federation’s October membership meeting.

Cherie described an evolution of her plan for emergency needs/resources collection/sharing.

Land Use—Fred Costello

The first rezoning for the Comprehensive Plan for Tysons is underway.

Meetings will be held in Reston on September 1 and 8 regarding rezoning. The county is moving toward a high jobs-to-residences ratio along the Dulles corridor. More traffic will result. This is not what Reston’s citizens had recommended.

Legislation—Frank Anderson

Board members were asked to review the Federation's 2011 legislative agenda and provide updates to the committee, including removing, adding and revising agenda items. The legislative agenda was distributed with the agenda and is available on the Federation's website.

Flint suggested that the format could better identify to whom recommendations are addressed: Commonwealth or Federal legislators. There was much discussion; the matter was referred to the committee for consideration.

This was the first board meeting for Jason Ha, the newly appointed committee co-chair.
