You raise a good point for discussion on Thursday. I'll surely reiterate this point at Thursday's meeting, but let me also state in advance: The Federation has not normally suggested a particular property tax rate. We don't pretend to know the "ideal" tax rate just as we don't necessarily know the "ideal" budget for, say, libraries or parks. IMO it's good to have some humility as an organization and not assert that we know all the ins and outs of the budget in areas where we just don't. On the other hand, we like to highlight areas where we support and/or oppose particular spending, and we give our reasoning for that.

There are, of course, ways to state our preference for utilizing a meals tax to alleviate lower residential property tax rates, minimizing cuts to existing programs, etc. We might, for example, stress in our introductory section our opinion that the level of residential property taxes overall cannot and should not continue to rise (given the affordability crisis, yada, yada), and that therefore "to the extent practicable" we advocate for any available tax relief to be applied to residential property tax rates. Personally I worry that we're putting the cart before the horse, here, and we should not take for granted that the BOS *will* enact a meals tax, and/or that they will enact it at 4%. But perhaps it is worth our time to spell out how the enactment of a meals tax would enable the Board to engage in their work more flexibly and nimbly. Best,

Averaged across the County, assessments are up 6.65% this year. Even if the tax rate were held level, what we pay will go up by that much this year; any increase to the tax rate just adds to that. (I'm keenly aware of this since my neighborhood is one that's pulling the average increase higher.)

Now that the BOS has voted to advertise a meals tax, we should discuss whether our resolution should support using "new" revenue from that tax (if it's enacted) to hold the line on the residential property tax rate, minimize cuts to existing programs, or bolster particular programs (e.g., schools or affordable housing).

The current draft supports diversifying the tax base without endorsing a particular strategy for taking advantage of the diversification. We may end up choosing to keep that approach, and there's nothing inherently wrong with doing so.

That said, I'm guessing our members may have strong opinions on how a meals tax would affect other taxes they pay. Staking out a position in the recommendation we make to the members would provide a point of focus for discussion at the membership meeting next week.

Charlotte.

Excellent questions. The short answer is these funds go into the General Fund and the BOS decides how they want to spend it with no restrictions more than any other General Fund revenue.

That said, I have heard different Supervisors discuss more money for affordable housing (Alcorn), reducing the \$59.5M of reductions, or reducing real estate taxes to give homeowners tax relief.

Some may remember in the 2016 referendum that Sharon Boluva promised if the referendum passed 60% would go to the school. That was a campaign promise of the chairman of the board that has long since retired. In other words, a completely new game.
